Membership of Gramex is free and is subject to the statutes and policies of Gramex at any given time, which can be found at www.gramex.dk.

Gramex manages our communication to the public and broadcasting rights for published sound recordings in the Danish territory according to compulsory license in section 68 of the Danish Copyright Act. The management includes both existing and future rights.

We hereby transfer the rights to transmission to the public and copying, which Gramex is authorized to administer, cf. the Danish Copyright Act § 2, para. 4, no. 1 and § 66. Unless otherwise agreed, the transfer includes the mandates at any given time, as stated on www.gramex.dk. The remuneration for copying is distributed among the respective producers, and the producer undertakes to further distribute a share of the received remuneration to the affected artists in accordance with the established provisions in the specific contracts with the artists.

We authorize Gramex to enforce any infringement of the above rights and to take any legal or factual steps necessary to protect them.

We will contact Gramex if we subsequently wish to change the countries in which Gramex manages our rights.

Upon request from Gramex we undertake to provide Gramex with a list of the recordings we have made, or to which we have lawfully acquired the rights, and to promptly provide information when we have produced new sound recordings, or when we have acquired or transferred rights to other sound recordings.

Remuneration is paid to the above-mentioned bank account, unless, for example, we are a member of a foreign sister organization covering the Danish territory. In that case, Gramex will pay remuneration to this sister organization. When Gramex represents us in Denmark, even if we choose not to be a member, it is due to the compulsory license in Section 68 of the Danish Copyright Act, which Gramex administers. Gramex is approved by the Ministry of Culture to collect payment for the use of published sound recordings in Denmark and pay remuneration either directly or through a representative.
